Verified Volunteers has trained personnel who can explain the information furnished to you, and can provide a written explanation of any coded information contained in your files. "Proper identification" includes documents such as a valid driver's license, Social Security card, military identification card or credit card. If necessary, Verified Volunteers may request additional information about your volunteerism and personal or family history to verify your identity.
